Anonymous. It does not ask for children's names or the name of their school or youth organisation.

Voluntary. Pupils do not have to take part. They may withdraw from the study at any time without giving a reason.

All data collected for the study will be protected in accordance with data protection laws and with the data protection policies of Snap Surveys, Cardiff University and the Children's Commissioner for Wales.
