Introduction:

Recap the previous lesson, highlighting the key aspects for the pupils.

Look at the picture pack once more; give pupils the opportunity to offer their ideas and opinions of children's rights. You may also want to print off the black and white versions as colouring activities.

Discuss what has been learned over the previous 9 lessons and the importance of children's rights.

Once again highlight Sally Holland the Children's Commissioner for Wales and her role.

Main Activity:

As an end to the scheme of work, celebrate each pupil's involvement in the lessons by giving certificates to each pupil.

You may wish to add in a fun group activity for the class to celebrate their success. Or you could make a display area or presentation to share the work they have done with the school community or families.

Plenary:

Ask pupils to finish any activities they haven't done in their "My Rights Booklet", consolidating their existing knowledge.

Invite Sally, the Children's Commissioner, or her team to come and meet your class to find out all about the work you have done about rights. You can share your rights booklets and show any displays you have done about rights.

<u>AFL:</u>

Understanding can be assessed through questioning and verbal feedback. Self-assessment will further AFL with the learners providing appropriate understanding for children's rights and the things they need to grow up happy, healthy and safe. Refer back to the lesson objectives, have they been achieved?

Differentiation:

- Support hearing impaired learners with appropriate sign language
- Support ASD/ low-level learners with PECS/ pictures of reference
