

CASE STUDIES – YOUTH WORK (scroll down for welsh)

A – Fateha is 14 years old and has been attending your youth provision for a year, she has a boyfriend Mark aged 15 and has confided in you that she thinks she maybe pregnant. She wants to go to the doctor but is scared of going alone and concerned her and Mark will get into trouble. You know's family as you work in a small community and think her parents would be devastated to find out Fateha is pregnant.

What rights are important here? What would you do?

B – Ali is 15 years old. He was apprehended at a rally for Black lives matter when an altercation broke out between police and demonstrators. He was placed in a police van. He and his parents claim that he was treated unfairly by police because he is black, you have worked with Ali for a number of years and he wants your support to challenge the police.

What rights are important here? What would you do?

C – Christian is 13 years old and attends a local comprehensive that you support. You expect that a large group of him and his friends smoke weed. On visiting the school to set up some sessional work you saw him dealing to a child in the year below, you were the only adult that saw this happen.

What rights are important here? What would you do?

D – Jordan aged 11 has mild learning difficulties and sometimes finds it difficult to control her behaviour. She attends a local high school and complains that she is being bullied by other pupils who tease her when she "gets angry" and that the staff don't do anything about it, she thinks her parents don't care either and asks you for help.

What rights are important here? What would you do?

E – Kezia is 13 and has been struggling because her friends and parents are not willing to accept her sexuality, she is keen to explore her sexuality and find other young people who understand her. She has asked for your advice.

What rights are important here? What would you do?

F – Noah is 14 years old and has attended your youth club for a couple of years. He has often displayed physical behaviour but the past couple of months this has gotten a lot more aggressive. A number of young people and parents/ guardians have raised concerns over incidents.

What rights are important here? What would you do?

A - Mae Fateha yn 14 oed ac wedi bod yn dod i'ch darpariaeth ieuenctid ers blwyddyn, mae ganddi gariad Mark sy'n 15 oed ac mae wedi dweud wrthyh chi ei bod hi'n meddwl gallai hi fod yn feichiog. Mae hi eisiau mynd at y meddyg, ond mae hi'n ofni mynd ar ei phen ei hun ac yn poeni bydd hi a Mark yn mynd i drwbwl. Rydych chi'n adnabod teulu Fateha achos rydych chi'n gweithio mewn cymuned fach ac rydych chi'n meddwl byddai darganfod bod Fateha'n feichiog yn torri calon ei rhieni.

B – Mae Ali yn 15 oed. Cafodd ei ddal mewn rali Mae Bywydau Du o Bwys (Black Lives Matter) pan fu gwrthdaro rhwng yr heddlu a'r protestwyr. Cafodd ei roi yn un o faniau'r heddlu. Mae ef a'i rieni'n honni bod yr heddlu wedi'i drin yn annheg oherwydd ei fod yn ddu. Rydych chi wedi gweithio gydag Ali am nifer o flynyddoedd, ac mae e eisiau eich cefnogaeth chi i herio'r heddlu.

Pa hawliau sy'n bwysig yma? Beth fydddech chi'n gwneud?

C – Mae Christian yn 13 oed ac yn mynd i ysgol gyfun leol rydych chi'n ei chefnogi. Rydych chi'n tybio bod grŵp mawr sy'n cynnwys Christian a'i ffrindiau yn smygu canabis. Wrth i chi ymweld â'r ysgol i baratoi gwaith sesiynol fe welsoch chi e'n delio'r cyffur i blentyn yn y flwyddyn nesaf i lawr. Chi oedd yr unig oedolyn a welodd hyn yn digwydd.

Pa hawliau sy'n bwysig yma? Beth fydddech chi'n gwneud?

D – Mae gan Jordan, sy'n 11 oed anawsterau dysgu cymedrol ac weithiau mae hi'n cael trafferth rheoli ei hymddygiad. Mae hi'n mynychu ysgol uwchradd leol ac yn cwyno ei bod yn cael ei bwlio gan ddisgyblion eraill sy'n ei phryfocio pan fydd hi'n "gwylltio" a bod y staff yn gwneud dim am y peth. Mae hi'n credu bod dim ots gan ei rhieni chwaith, ac mae hi'n gofyn am eich help chi.

Pa hawliau sy'n bwysig yma? Beth fydddech chi'n gwneud?

E – Mae Kezia yn 13 ac mae hi wedi bod yn cael trafferth ymdopi oherwydd bod ei ffrindiau a'i rhieni ddim yn barod i dderbyn ei rhywioldeb. Mae hi'n awyddus i archwilio'i rhywioldeb a dod o hyd i bobl ifanc eraill sy'n ei deall. Mae wedi gofyn am eich cyngor.

F – Mae Noah yn 14 oed ac wedi bod yn dod i'ch clwb ieuenctid ers nifer o flynyddoedd. Mae'n aml wedi arddangos ymddygiad corfforol, ond yn ystod y misoedd diwethaf mae wedi mynd yn llawer mwy ymosodol. Mae nifer o bobl ifanc a rhieni/gwarcheidwaid wedi mynegi pryderon ynghylch digwyddiadau.
